These terms and conditions will be published on Stoll's website www.stoll.org.uk/lottery.
- 2. You represent and agree that:
  - a. You are 18 years of age or over.
  - b. You are a resident of the United Kingdom.
  - c. You will not buy or purport to buy an entry in this Lottery on behalf of anybody under the age of 18.
  - d. You will provide accurate entry information, including your name, personal address, email and telephone number.
- 3. You agree that you shall not be entitled to receive any prize if you are unable to substantiate to the Promoter your representations under paragraph 2.
